

# **Instructions Regarding Admission of Attorneys to the Quinault Tribal Bar**

## **\$75 Application Fee**

In order to be admitted to the Quinault Tribal Court Bar; pursuant to Q.T.C. section 30.12.030, you must already be a member in good standing of the bar of any *state* of the United States or the District of Columbia. The following steps are further required for admission:

- I. Complete the attached four (4) page document entitled “Application for Admission to the Quinault Tribal Court Bar.”
2. Arrange for the completion of the document entitled “Certificates of Good Moral Character.”
3. Return both completed documents to the Quinault Tribal Court, directed to the attention of **Court Manager**.
4. Prior to being admitted to the Quinault Tribal Court Bar the Court will require proof of a current **Quinault Business License** with the Quinault Indian Nation.
5. An annual bar due of \$50.00 is due by January 10<sup>th</sup> of each calendar year to remain in good standing of the Quinault Tribal Court Bar.
